## Coach House offers two new models

**C**oach House, Inc., introduces two exciting new entries in the Platinum™ line of downsized Class C motorhomes.

First up is the new Platinum 221XL, featuring a wide-open living area that makes it feel like a much larger RV. As you and your friends relax in comfort, you will hardly believe you are inside a downsized Class C motorhome!

What's the secret? The kitchen and bath are together in the rear, allowing the front to be devoted to living space. Sleeping accommodations are provided by a motorized sofa/bed that goes from daytime entertaining to nighttime slumbering at the touch of a button. The sofa/bed is contained in its own trouble-free HWH hydraulic slideout, providing more legroom by day, and leaving the center

aisle open even with the sofa down.

The 221XL is being offered with Coach House's popular Side Dinette floor plan.

The other new Coach House model, the Platinum 232XL, answers the question, "How much luxury can you build into an easy-to-drive 23-foot motorhome?" Well,

check it these features: Permanent double bed. Full bathroom with an enclosed stand-up shower and separate porcelain commode. Well-equipped kitchen with sink, stove, refrigerator and microwave/convection oven. Plenty of room for dining and relaxing. Entertainment center.

Not one but two hydraulic slideouts provide the room for so many luxury features. At the push of a button, the front sofa or dinette slides out, opening up valuable space in the heart of the unit, where you will be cooking, relaxing or entertaining. Push another button, and the double bed in the rear slides out, providing easy access to the bathroom and storage.

The Platinum 232XL is available in a Front Dinette or a Front Sofa floor plan.

## RV driving: It's different, but not difficult

**D**riving an RV is much easier than many would think, especially driving one of our wonderful Coach Houses. Regardless of the seeming ease, novices and even experienced RVers can benefit from the following pointers:

- 1.** Before leaving on a trip, adjust all mirrors and cameras for optimal road visibility. Remember to use the mirrors and cameras once adjusted.
- 2.** Take the size of your vehicle into consideration when turning. The front and rear wheels will track paths much farther apart than those of a car.
- 3.** Allow more time to brake, change lanes and enter highways, since larger vehicles take more time to accelerate and slow down.
- 4.** Back up with caution. It is a good idea to have someone outside the vehicle assist the driver in backing to avoid obstacles not seen in the mirrors or camera. An ounce of prevention is more important than worrying about embarrassing oneself. If another person is not available, inspect the area behind the vehicle before backing up.

**5.** In order to assure that you haven't added more weight than your motor home is rated to handle, periodically have your loaded RV weighed at a commercial scale (used by moving vans).

Drivers towing vehicles should also:

- 1.** Match the proper tow vehicle to your RV. Look at the owner's manual to determine the maximum load your RV can pull. Remember that only certain cars are considered towable, and many vehicle manufacturers have special

instructions for towing their vehicles. Towing a vehicle not rated for towing or not following instructions for towing a vehicle may void certain warranties.

- 2.** Use the right trailer hitch and make sure it is hitched correctly.
- 3.** Connect lights and confirm that the towed vehicle's brakes, turn signals and tail lights are synchronized with the towing vehicle's.
- 4.** Be aware: Backing up may not be an option with certain towing systems.

## Smoky Mountain Rally a huge success

Over 70 coaches participated in the 7th Annual Coach House Rally held at Holly Haven RV Park in Pigeon Forge, Tenn., October 26–29. Located in East Tennessee, Pigeon Forge is surrounded by the beauty of the Great Smoky Mountains. And, they were truly spectacular at the height of fall foliage where the colors were almost too vibrant to describe. We suffered through unseasonably cold and wet weather, but our spirits were undeterred.

For those who may not be aware of the history surrounding the area, Pigeon Forge's first business was established in 1820 when Isaac Love built an iron forge on the Little Pigeon River (thus the name "Pigeon Forge") and its population grew slowly into the next century. However, the lure of the mountains brought more and more visitors to the area, and new businesses sprung up to meet the needs of the travelers. By the late 1980s, the opening of Dollywood entertainment park turned Pigeon Forge into a major tourist destination, with more than 11 million people visiting each year. At times, when we

We arrived on Thursday to a wine and cheese reception, followed by one of the many wonderful meals provided in the pavilion. On Friday, chartered buses carried us through some beautiful scenery to nearby Gatlinburg, a Swiss-style village. If you wanted an old-timey photo or tee-shirt, you had come to the right place. A ride on America's largest aerial tramway from Gatlinburg up into the Smokies was breathtaking despite the heavy cloud layer. That evening, we were front-row guests at Fiddlers' Feast, a dinner show featuring the Smokies' legacy, food, music and humor.

Saturday afternoon, CHOC conducted its general membership meeting at which a new slate of officers was elected. **T**he Coach House Owners' Club is a chapter of the Family Motor Coach Association. FMCA is an international organization for people who own and enjoy the recreational use of motorized, self-contained recreation vehicles (motorhomes).

Membership in FMCA is required for membership in any FMCA chapter, including CHOC.

FMCA is divided into nine geographical Areas in addition to the International Area. The International Area consists of FMCA chapters formed by some special interest as opposed to geographical boundaries. As CHOC was formed for owners of Coach House motor homes, we are part of the International Area. Members may belong to one or more chapters. Periodically, Family Motor Coaching Magazine publishes a Chapter Directory, which includes complete list of chapters divided by Area. This information is also available on the FMCA web site, [www.fmca.com](http://www.fmca.com).

At our recent CHOC business meeting, held at the Pigeon Forge CHOC Homecoming Rally, we satisfied our chapter duty and responsibility to elect a

President, one or more Vice Presidents, a Secretary, a Treasurer, a National Director, and an Alternate National Director for a one- or two-year term. One person may hold two offices, as is the case with Jack Mowrer, elected as Secretary and Treasurer.
